I. The following are revisions to the Specifications:

1. The following revisions shall be made to SECTION 26 05 53 – IDENTIFICATION FOR ELECTRICAL SYSTEMS:

A. Page 26 05 53-4, under subparagraph 3.01.J delete the following:

“J. Power Circuit Identification: Use metal tags or aluminum wraparound marker bands for cables, feeders, and power circuits in pull boxes, junction boxes, and switchboard rooms.”

and replace with:

“J. Power Circuit Identification: Use metal tags or aluminum wraparound marker bands for cables, feeders, and power circuits in pull boxes, junction boxes, VFDs, MCCs, control panels, and electrical rooms.”

2. The following revisions shall be made to SECTION 26 29 23 – VARIABLE FREQUENCY DRIVE EQUIPMENT:

A. Page 26 29 23-1, under 1.04, add the following:

“D. Provide (2) hard copy of FINAL AS-BUILT drawings with owner, and (1) hard copy in field with device.”

3. The following revisions shall be made to SECTION 26 44 00 – PROCESS PIPING HEAT TRACING:

A. Page 26 44 00-1, under 1.03, add the following:

“D. Provide (2) hard copy of FINAL AS-BUILT drawings with owner, and (1) hard copy in field with device.”

4. The following revisions shall be made to SECTION 46 33 33 – POLYMER MIXING EQUIPMENT:

A. Page 26 44 00-1, under 1.03, add the following:

“D. Provide (2) hard copy of FINAL AS-BUILT drawings with owner, and (1) hard copy in field with device.”
